The call is reserved to qualified ESCOs for the granting of the concession for energy efficiency services and energy management with fuel supply for about 60 buildings located in the 4 provinces of Liguria Region.

Better public investment thanks to efficient and professional procurement

To strengthen the single market, the European Commission presented an initiative to organize public procurement in a more efficient and sustainable way, taking full advantage of digital technologies to simplify and expedite the procedure.

The initiative envisages four main topics:

1. the definition of specific priority areas for improvement: increased use of the criteria of innovation, environmental friendliness and social responsibility for the award of public contracts; better access of SMEs to EU procurement markets and easier access for EU firms to third country procurement markets; greater transparency, integrity and quality of procurement data; digitization of procurement procedures and enhanced cooperation between public purchasers across the EU;
2. ex ante voluntary evaluation of major infrastructure projects through a helpdesk to be set up by the Commission. The helpdesk will be able to answer specific questions in the early stages of projects with an estimated value of 250 million euro and through the full procurement procedure for projects above 500 million Euros, thus significantly reducing the uncertainty and the risk of delays and legal disputes;

3. the professionalization of public purchasers;
4. stimulating innovation through public procurement, both towards the procurement of innovative products/services and through the application of innovative purchasing models. On this topic, the Commission recently launched a public consultation aimed at receiving feedback by all stakeholder on how to stimulate innovation in public procurement which will be open until 31 December 2017.
